- Share any photos, videos, fabric swatches and paint colors of the space in which you plan to display the piece.
- Review my website and social media for inspiration and ideas.
- Once the plan is created and agreement signed, I begin to create and will share 4 small rough paintings with you.
- After seeing the rough ideas in your space you will share notes with me outlining your likes and dislikes.
- From the notes and discussion, I begin to work on the piece and will share updates along the way. I want to be sure we are invisioning the same final piece of artwork.
- The piece will not be completely finished without your approval and the time line will be made very clear from the beginning.

PROGRESS REPORTS: Artist agrees to furnish the Purchaser with progress reports during the creation of the work, which can include pictures of the work in progress. The pictures may be digital images and sent via email.

COPYRIGHT: Upon final payment for the work, the Purchaser becomes the legal owner.
The Artist reserves the common- law copyright to all works commissioned by the Purchaser that are created by the Artist, including all reproduction rights. The artwork may not be reproduced without the prior written approval of the Artist.

REPRODUCTION RIGHTS: Artist retains all copyright rights and rights to reproduce the work in all forms.
RIGHT OF REFUSAL: After completion of the work, if the Purchaser is not satisfied, the Artist will retain the refused work and the nonrefundable deposit, and the Purchaser will owe no additional fees.

NOTICE: The Artist has the right to sign and date the work. Placement and size to be determined by the Artist.
